**ROAD TRAFFIC AND VEHICLES**

**The Parking and Waiting Restrictions (Dromore) Order  
(Northern Ireland) 2010**

*Made* - - - - - *3rd February 2010*

*Coming into operation* - *26th February 2010*

The Department for Regional Development<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Articles 4(1), (2) and (3), 10(4) and 13(1), (13) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

It appears to the Department to be necessary to provide a suitable parking place for vehicles on the parts of the road specified in Schedule 1.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedules 1 and 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a Notice in compliance with paragraphs 1 and 3 of those Schedules.

The Department, in compliance with paragraph 3(4) of Schedule 4 to that Order, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

**Citation, commencement and interpretation**

**1.**—(1) This Order may be cited as The Parking and Waiting Restrictions (Dromore) Order (Northern Ireland) 2010 and shall come into operation on 26th February 2010.

(2) In this Order—

“parking place” means a length of road authorised by Article 2 to be used as a parking place;

“parking space” means a space which is marked out in a parking place for the leaving of a vehicle;

“specified hours” means the hours between 8.30 a.m. and 6.15 p.m. on Monday to Saturday inclusive.

### **Authorisation of parking place**

2. The use as a parking place of the lengths of road specified in Schedule 1 is authorised.

### **Use of parking places**

3. Save as provided in Article 6, a person shall not leave or cause a vehicle other than a car, motor cycle or light goods vehicle to be left during the specified hours within the limits of a parking place.

### **Position within a parking place**

4. Save as provided in Article 6, a person shall not leave or cause a vehicle to be left in a parking place unless it is wholly within a parking space where such has been marked out.

### **Maximum period and further use of a parking place**

- 5.—(1) Subject to paragraph (2) and save as provided in Article 6, during the specified hours—
- (a) a person shall not leave or cause a vehicle to be left in a parking place for longer than 30 minutes;
  - (b) a person shall not leave or cause that vehicle to be left again in that parking place, until the expiration of 30 minutes from the time that vehicle is removed from that parking place.
- (2) The prohibitions in paragraph (1) shall not apply to a disabled person’s vehicle.

### **Exceptions**

6.—(1) Nothing in Articles 3, 4 and 5(1) shall render it unlawful to leave or cause a vehicle to be left in a parking place where the person in control of it is prevented from proceeding by circumstances beyond the person’s control or to avoid an accident or for so long as may be reasonably necessary to enable—

- (a) the vehicle to be used for fire brigade, ambulance, police or customs purposes or for the purposes of the security forces;
- (b) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in section 125 of the Postal Services Act 2000(a);
- (c) the vehicle, if it cannot conveniently be used for such purpose outside that parking place, to be used—
  - (i) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
  - (ii) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker’s functions;
  - (iii) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992(b) or of a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996(c); or

- (iv) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984(a); or
- (d) goods to be loaded or unloaded from the vehicle.

### **Suspension of the use of a parking place**

7. The Department may suspend the use of a parking place or any part of it for so long as may be necessary for the purpose of enabling—

- (a) a vehicle, if it cannot conveniently be used for such purpose outside the parking place, to be used in connection with any of the following purposes—
  - (i) building, repair or demolition operations, including works to property adjacent to the parking place;
  - (ii) the removal of any obstruction to traffic;
  - (iii) the cleansing, maintenance, improvement or reconstruction of the road;
- (b) the implementation of any traffic management scheme;
- (c) street works as defined in Article 3(3) of the Street Works (Northern Ireland) Order 1995(b) to be executed.

### **Prohibition of the use of a suspended parking place**

8. A person not using a vehicle in connection with any of the undertakings specified in Article 7 shall not leave or cause that vehicle to be left in a parking place where the use of that parking place has been suspended by the Department in accordance with that Article.

### **Removal of a vehicle in an emergency**

9. A person authorised by the Department may remove a vehicle from a parking place in an emergency.

### **Method of removal of a vehicle**

10. Any person removing a vehicle by virtue of Article 9 may do so by towing, or driving the vehicle or in such other manner as is reasonably necessary and may take such measures as are reasonably necessary to enable him to remove it.

### **Custody of a vehicle**

11. When a person authorised by the Department removes or makes arrangements for the removal of a vehicle from a parking place by virtue of Article 9 that person shall make such arrangements as may be necessary for the safe custody of the vehicle.

### **Parts of road on which vehicles must not wait**

12. Save as provided in Article 13, a person shall not cause or permit a vehicle to wait on the lengths of road specified in Schedule 2 at any time.

### **Exceptions**

13.—(1) Nothing in Article 12 shall render it unlawful to cause or permit a vehicle to wait on the carriageway of a length of road specified in Schedule 2 for so long as may be reasonably necessary to enable—

- (a) a person to board or alight from a vehicle provided that such boarding or alighting does not cause the vehicle to wait in the same place for more than 2 minutes;
- (b) the vehicle to be used for fire brigade, ambulance, police or customs purposes or the purposes of the security forces;
- (c) the vehicle to be used for the purposes of delivering or collecting postal packets as defined in section 125 of the Postal Services Act 2000;
- (d) the vehicle to wait where the person in control of it is prevented from proceeding by circumstances beyond that person's control or to avoid an accident;
- (e) the vehicle, if it cannot conveniently be used for such purposes outside that length of road, to be used—
  - (i) in connection with any building, repair or demolition operations;
  - (ii) in connection with the removal of any obstruction to traffic;
  - (iii) by or on behalf of a district council or a government department in pursuance of statutory powers or duties;
  - (iv) by or on behalf of a sewerage undertaker or a water undertaker in connection with the discharge of that undertaker's functions;
  - (v) in connection with the discharge of the functions of the holder of a licence granted under Article 10 of the Electricity (Northern Ireland) Order 1992 or of a licence granted under Article 8 of the Gas (Northern Ireland) Order 1996; or
  - (vi) in connection with the laying, erection, alteration or repair of any electronic communications apparatus as defined in Schedule 2 to the Telecommunications Act 1984.
- (f) goods to be loaded or unloaded from the vehicle.

(2) For the purposes of paragraph (1)(a) a vehicle shall be deemed to wait for more than 2 minutes in the same place if any one part of carriageway is below any part of the vehicle or its load (if any) throughout a period exceeding 2 minutes whether or not the vehicle is moved during that period.

## SCHEDULE 1

Articles 1(2) and 2

### Parking Place

Monday to Saturday 8.30 a.m. to 6.15 p.m.

Maximum stay 30 minutes; No return within 30 minutes

All in the town of Dromore, County Down

1. Gallows Street (west side), from a point 9 metres south of its junction with Lottery Place for a distance of 18 metres in a southerly direction
2. Gallows Street (west side), from a point 11 metres north of its junction with Lottery Place for a distance of 12 metres in a northerly direction

## SCHEDULE 2

Article 12

### No Waiting at any Time

All in the town of Dromore, County Down

1. Gallows Street (west side) from a point 18 metres north of its junction with Church Street for a distance of 18 metres in a northerly direction
2. Meeting Street (north-east side) from a point 38 metres north-west of its junction with Circular Road for a distance of 6 metres in a north-westerly direction
3. Church Street (north side) from a point 15 metres east of its junction with Church View for a distance of 27 metres in an easterly direction

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order authorises the use as a parking place of the lengths of road specified in Schedule 1 (Article 2) and prescribes the conditions under which the parking place may be used (Articles 3, 4, 5 and 8). Vehicles are excepted from the conditions in certain circumstances (Article 6). The Order also makes provision for the suspension of the use of a parking place (Article 7) and for the removal of a vehicle from a parking place in an emergency (Articles 9, 10 and 11).

The Order also prohibits vehicles from waiting on the lengths of road specified in Schedule 2 (Article 12). Vehicles are excepted from the prohibition in certain circumstances (Article 13).

A penalty charge (£60) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.
