ROAD TRAFFIC AND VEHICLES

The Prohibition of Right-Hand Turn (Newry) Order (Northern Ireland) 2010

Made - - - - *29th November 2010*

Coming into operation - *21st December 2010*

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as the Department considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Prohibition of Right-Hand Turn (Newry) Order (Northern Ireland) 2010 and shall come into operation on 21st December 2010.

Prohibition of right-hand turn

2. Subject to Article 3 a person shall not cause or permit a vehicle proceeding on a road specified in column 1 of the Schedule to make a right-hand turn into the road specified in the corresponding entry in column 2 while proceeding in the direction specified in the corresponding entry in column 3.

Exceptions

3. Article 2 shall not apply to—

- (a) a vehicle being used for fire and rescue, ambulance, police or military purposes; or
- (b) a vehicle, the driver or rider of which is acting upon the direction or with permission of a constable in uniform.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order prohibits vehicles travelling in a southerly direction along Derrybeg Lane from making a right-hand turn into Craigmore Way, Newry; and vehicles travelling in a south-westerly direction along Craigmore Way from making a right-hand turn into Derrybeg Lane, Newry.

Any person who acts in contravention of the Order shall be guilty of an offence under the Road Traffic Regulation (Northern Ireland) Order 1997 (“the Regulation Order”) and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (£1,000), in accordance with the Road Traffic Offenders (Northern Ireland) Order 1996 as amended by the Regulation Order.

Traffic signs indicating the effect of the Order will in due course be erected on the roads.
