**The Prohibition of Waiting (Schools) (Amendment No. 2) Order  
(Northern Ireland) 2018**

*Made* - - - - - *28th August 2018*

*Coming into operation* - *17th September 2018*

The Department for Infrastructure<sup>(a)</sup> makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997<sup>(b)</sup> and now vested in it<sup>(c)</sup>.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

**Citation and commencement**

1. This Order may be cited as The Prohibition of Waiting (Schools) (Amendment No. 2) Order (Northern Ireland) 2018 and shall come into operation on 17th September 2018.

**Amendment**

2. The Prohibition of Waiting (Schools) Order (Northern Ireland) 2015<sup>(d)</sup> is amended by the addition to Schedule 2 of the following items—

“31.	Abbey Road, Millisle (south-east side) – from a point 15 metres north-east of its junction with Churchill Avenue for a distance of 40 metres in a north-easterly direction.	8.30 a.m. to 9.15 a.m. and 1.45 p.m. to 3.15 p.m.	Monday to Friday inclusive	31st August to 30th June

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends The Prohibition of Waiting (Schools) Order (Northern Ireland) 2015 (“the Order”) by the addition to Schedule 2 of the items specified in Article 2 relating to Abbey Road, Millisle and New Harbour Road, Portavogie.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
