**ROAD TRAFFIC AND VEHICLES**

**The Prohibition of Waiting (Schools) (Amendment) Order  
(Northern Ireland) 2018**

*Made* - - - - - *14th February 2018*

*Coming into operation* - *5th March 2018*

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objections or other representations have been received.

**Citation and commencement**

1. This Order may be cited as The Prohibition of Waiting (Schools) (Amendment) Order (Northern Ireland) 2018 and shall come into operation on 5th March 2018.

**Amendment**

2. The Prohibition of Waiting (Schools) Order (Northern Ireland) 2015(d) is amended by the addition to Schedule 2 of the following items—

“28.	Albany Road, Bangor (north-east side) – from a point 54.5 metres south-east of its junction with Ashbury Avenue for a distance of 33 metres in a south-easterly direction.	8.30 a.m. to 9.15 a.m. and 1.45 p.m. to 3.15 p.m.	Monday to Friday inclusive	31st August to 30th June

30.	Cootehall Road, Crawfordsburn (east side) – from a point 74 metres south of its junction with Crawfordsburn Road for a distance of 92 metres in a southerly direction.	8.30 a.m. to 9.15 a.m. and 1.45 p.m. to 3.15 p.m.	Monday to Friday inclusive	31st August to 30th June”

### **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends The Prohibition of Waiting (Schools) Order (Northern Ireland) 2015 (“the Order”) by the addition to Schedule 2 of the items specified in Article 2 relating to Albany Road and Ashbury Avenue, Bangor and Cootehall Road Crawfordsburn.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
