ROAD TRAFFIC

The North East Unit Trunk Roads Area (Temporary Prohibitions of Traffic, Temporary Prohibitions of Overtaking and Temporary Speed Restrictions) (No. 12) Order 2010

Made

20th December 2010

Coming into force

1st January 2011

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1), 14(1) and (4), of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1) of that Act they are satisfied that the traffic on the lengths of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near the said lengths of road.

In accordance with section 14(3) of that Act they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the North East Unit Trunk Roads Area (Temporary Prohibitions of Traffic, Temporary Prohibitions of Overtaking and Temporary Speed Restrictions) (No. 12) Order 2010, comes into force on 1st January 2011 and ceases to have effect at 0001 hours on 1st April 2011.

Interpretation

2. In this Order a reference to a numbered column is to the column in the Schedule bearing that number.

Temporary prohibition on use of a road

3. Subject to article 6, no person shall use, or permit the use of, any vehicle on each length of road specified in column 1 when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(b).

Temporary prohibition on overtaking

4.—(1) Subject to paragraph (2), no person shall use, or permit the use of, any vehicle in such a way that it overtakes any other moving vehicle on each length of road specified in column 1 when a prohibition is identified as applying to a part or parts of that length of road by means of a traffic sign prescribed in Diagram 632 of the Traffic Signs Regulations 2002.

(2) Nothing in paragraph (1) shall prohibit any person from using, or permitting the use of, any vehicle in such a way that it overtakes a cycle, motor cycle, tricycle or any other vehicle not being a motor vehicle in accordance with section 140 of the Road Traffic Regulation Act 1984^(a).

Temporary speed restriction

5.—(1) Subject to paragraph (2), no person shall drive any vehicle on the lengths of road specified in column 1 of Parts 2 and 3 of the Schedule at a speed exceeding that specified in column 2 when a restriction is identified as applying to a part or parts of that length of road by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.

(2) When convoy working is in operation and indicated by one or more of the traffic signs prescribed in Diagrams 7011, 7025, 7026, 7027, 7028 and 7029 of the Traffic Signs Regulations 2002, no person shall drive any vehicle on the lengths of road specified in column 1 of Part 3 of the Schedule at a speed exceeding 10 mph when a restriction is identified as applying to a part or parts of that length of road by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.

Exemption for emergency and works vehicles

6. Article 3 does not apply to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.

Description of particular lengths of road
1. That length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the entire length of the southbound on slip road from the junction with the A912 Edinburgh Road, Perth to the junction with the M90 Perth Southern Bypass, a distance of 600 metres or thereby.
2. That length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the entire length of the southbound off slip road from its junction with the M90/A90 Inverkeithing – Fraserburgh Trunk Road at Friarton Bridge, Perth, in a general southward direction to its junction with the Perth Southern Bypass, Perth, a distance of 1.12 kilometres or thereby.
3. That length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the entire length of the northbound off slip road to the Perth Southern Bypass, a distance of 1.74 kilometres or thereby.
4. That length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the entire length of the southbound carriageway of the Perth Southern Bypass from the junction with the northbound off slip road leading to Friarton Bridge in a generally southwards direction to its junction with the M90/A90 Inverkeithing – Fraserburgh Trunk Road, a distance of 1.15 kilometres or thereby.
5. That length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the entire length of the northbound slip road from the Perth Southern Bypass, Perth, in a general northward direction to its junction with the M90/A90 Inverkeithing – Fraserburgh Trunk Road at Friarton Bridge, Perth, a distance of 890 metres or thereby.
6. That length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the entire length of the southbound off slip road at Inchture Grade Separated Junction, a distance of 300 metres or thereby.
7. That length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the entire length of the northbound off slip road at Portlethen Grade Separated Junction, a distance of 510 metres or thereby.
8. That length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the entire length of the southbound off slip road at Charlestown Grade Separated Junction, Aberdeen, a distance of 300 metres or thereby.
9. That length of the A96 Aberdeen – Inverness Trunk Road being the eastbound and westbound carriageways from its junction with Oldmeldrum Road Roundabout, Aberdeen eastwards to its junction with the M90/A90 Inverkeithing – Fraserburgh Trunk Road at Haudagain Roundabout, a distance of 2.12 kilometres or thereby.
10. That length of the A96 Aberdeen – Inverness Trunk Road from its junction with Barn Church Road, Culloden westwards to the Smithton Roundabout, a distance of 3.56 kilometres or thereby.

21. That length of the A96 Aberdeen – Inverness Trunk Road from its junction with the Huntly Roundabout, Huntly, eastwards to its junction with the A920 Oldmeldrum Junction, a distance of 9.189 kilometres or thereby.		30 mph
22. That length of the A96 Aberdeen – Inverness Trunk Road from its junction with the B9115 Drummuir Junction, westwards to its junction with the A98 Lennox Crescent Roundabout, Fochabers, a distance of 17.773 kilometres or thereby.		30 mph
23. That length of the A96 Aberdeen – Inverness Trunk Road from its junction with the A9 at Raigmore Interchange, Inverness, eastwards to its junction with the Greshop Roundabout, Forres, a distance of 39.583 kilometres or thereby.		30 mph
