**ROAD TRAFFIC**

**The A47 Trunk Road (A141 Guyhirn Roundabout to B198  
Redmoor Lane Roundabout, Wisbech, Cambridgeshire)  
(Temporary Prohibition of Traffic) Order 2011**

*Made* - - - - *27th January 2011*

*Coming into force* - - *3rd February 2011*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A47 Trunk Road (“the A47”), is satisfied that traffic on road that in the County of Cambridgeshire should be prohibited because works are proposed to be executed thereon:

NOW THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order:

1. This Order may be cited as the A47 Trunk Road (A141 Guyhirn Roundabout to B198 Redmoor Lane Roundabout, Wisbech, Cambridgeshire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 3rd February 2011.

2. In this Order -

“the trunk road” means the A47 at Wisbech between its junctions with the A141 Guyhirn Roundabout and the B198 Redmoor Lane Roundabout;

“lay-by” means an area of carriageway, intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(b); and in this definition “carriageway” means a way constituting or comprised in the trunk road (other than a cycle track) over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

“works” mean resurfacing, white lining and associated works to the trunk road;

“a works period” means a period of 10 hours starting at 20.00 hours on Friday 4 February 2011 or on any subsequent day until the works have been completed;

“the works period” means the period starting at 00.01 hours on Friday 4 February 2011 and ending when the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4 no person shall cause or permit any vehicle to enter or proceed in –

- (a) the trunk road, during a works period, or
- (b) any lay-by adjacent to the trunk road, during the works period.

4. The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to a vehicle being used for, or in connection with, the works or for police, fire and rescue authority, ambulance, traffic officer or winter service maintenance purposes.
