**ROAD TRAFFIC**

**The A42 Trunk Road (Packington to Appleby Magna,  
Leicestershire) (Temporary Prohibition of Traffic) Order 2011**

*Made* - - - - *11th February 2011*

*Coming into force* - - - *18th February 2011*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A42 Trunk Road (“the A42”) and connecting roads, is satisfied that traffic on a length of that road and one of those connecting roads between Packington and Appleby Magna in the County of Leicestershire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order: -

1. This Order may be cited as the A42 Trunk Road (Packington to Appleby Magna, Leicestershire) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 18th February 2011.

2. In this Order:

| “the trunk road” | means the southbound carriageway of the A42 from its junction with the slip road leading to its roundabout junction with the A5006, Measham Road (Junction 12) to its junction with the M42 at Junction 11;  |
| “the slip road”  | means the slip road leading to the southbound carriageway of the A42 from its roundabout junction with the A5006, Measham Road (Junction 12);  |
| “layby”          | means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition “carriageway” means any way (other than a cycle track) comprised in a length of the trunk road over which the |

public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

“the works period” means the period starting at 22.00 hours on Monday 21st February 2011 and ending when the said works have been completed,

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or the slip road.

4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the layby adjacent to the southbound carriageway of the A42 approximately 173 metres south of the centreline of the River Mease Bridge.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable; or
- (c) being used for or in connection with the said works.
