**The Trading with the Enemy (Transfer of Negotiable  
Instruments, etc.) (Revocation) Order 2012**

*Coming into force* - - - - - *25th May 2012*

The Treasury, in exercise of the powers conferred by sections 4 and 15(5) of the Trading with the Enemy Act 1939(a), make the following Order:

**Citation and commencement**

1. This Order may be cited as the Trading with the Enemy (Transfer of Negotiable Instruments, etc.) (Revocation) Order 2012 and comes into force on 25th May 2012.

**Revocation**

2. The instruments specified in the Schedule are revoked.
