**ROAD TRAFFIC**

**The A5036 Trunk Road (Junctions with the A5038 Netherton Way and the B5194 Copy Lane, Litherland) (Temporary Prohibition of Traffic) Order 2012**

*Made* - - - - *7th March 2012*

*Coming into force* - - *23rd March 2012*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A5036 Trunk Road, is satisfied that traffic on lengths of that road in the Borough of Sefton in Merseyside should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984 (a), hereby makes the following Order.

1. This Order may be cited as the A5036 Trunk Road (Junctions with the A5038 Netherton Way and the B5194 Copy Lane, Litherland) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 23rd March 2012.

2. In this Order;

“trunk road” means the A5036 Trunk Road;

“works” means resurfacing, road marking and general maintenance works on the trunk road;

“the works period” means periods overnight between 2200 hours and 0700 hours (ending at 0500 hours on weekdays and 0700 hours on Saturday and Sunday mornings) during a period starting on Saturday 24 March 2012 and ending on Saturday 31 March 2012. However, work may start and continue between the same times on subsequent nights or continue overnight until completed, for such period not exceeding 18 months as shall be required to complete the work;

“the first length of carriageway” means the eastbound carriageway of the trunk road between the junction of the trunk road with the A5038 Netherton Way and the junction of the trunk road with the B5194 Copy Lane;

“the second length of carriageway” means the westbound carriageway of the trunk road between the junction of the trunk road with the B5194 Copy Lane and the junction of the trunk road with the A5038 Netherton Way;

- 3.** Subject as mentioned in article 16 of this Order, during the works period, no person shall cause or permit any vehicle to enter or proceed in the first and second lengths of carriageway.
- 4.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn left onto the eastbound carriageway of the trunk road from Boundary Road.
- 5.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn left onto the eastbound carriageway of the trunk road from Park Lane West.
- 6.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn left onto the eastbound carriageway of the trunk road from Sefton Retail Park.
- 7.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn right onto the eastbound carriageway of the trunk road from the A5038 Netherton Way.
- 8.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn right onto the eastbound carriageway of the trunk road from Park Lane.
- 9.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn right onto the eastbound carriageway of the trunk road from Heysham Road.
- 10.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn left onto the westbound carriageway of the trunk road from the B5194 Copy Lane.
- 11.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn left onto the westbound carriageway of the trunk road from Heysham Road.
- 12.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn left onto the westbound carriageway of the trunk road from Park Lane.
- 13.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn right onto the westbound carriageway of the trunk road from the B5194 Copy Lane.
- 14.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn right onto the westbound carriageway of the trunk road from Sefton Retail Park.
- 15.** Subject as mentioned in article 16 of this Order no person shall, during the works period, cause or permit any vehicle to turn right onto the westbound carriageway of the trunk road from Park Lane West.
- 16.** The provisions of articles 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14 and 15 of this Order shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle being used for emergency purposes by the police, fire and rescue or ambulance services, vehicles being used in connection with the works, or by traffic officers, or to any vehicle proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform.
