**The Air Navigation (Restriction of Flying) (Dunsfold)
Regulations 2013**

Made - - - - - *25th April 2013*

Coming into force - - - - - *24th August 2013*

The Secretary of State deems it necessary in the public interest to restrict flying in the vicinity of Dunsfold, Surrey, by reason of a flying display scheduled to take place there on 24th and 25th August 2013.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Dunsfold) Regulations 2013 and come into force on 24th August 2013.

Interpretation

2. In regulation 3 all times referred to are Co-ordinated Universal Time.

Restricted airspace

3.—(1) Subject to paragraph (2), between 1030 hours and 1730 hours on 24th and 25th August 2013 no aircraft is to fly—

- (a) below 2,500 feet above mean sea level within the area bounded by—
 - (i) an anticlockwise arc of a circle having a radius of 12 nautical miles whose centre is at 510853N 0001125W, from 510949N 0003025W to 510440N 0002914W, and
 - (ii) a clockwise arc of a circle having a radius of 3 nautical miles whose centre is at 510702N 0003209W, from 510440N 0002914W to 510949N 0003025W; or
- (b) below 1,500 feet above mean sea level within the elliptical area bounded by—
 - (i) a clockwise arc of a circle having a radius of 3 nautical miles whose centre is at 510702N 0003209W, from 510949N 0003025W to 510440N 0002914W, and
 - (ii) a clockwise arc of a circle having a radius of 12 nautical miles whose centre is at 510853N 0001125W, from 510440N 0002914W to 510949N 0003025W.

(2) Paragraph (1) does not apply to any aircraft flying with the permission of the Dunsfold air show flying display director.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in airspace in the vicinity of Dunsfold, Surrey by reason of an air display that is scheduled to take place there on 24th and 25th August 2013. The air display will involve a large number of civil and military aircraft in high-energy manoeuvres and the Civil Aviation Authority's Directorate of Airspace Policy (DAP), in agreement with the Department for Transport, considers that flying should be restricted in the vicinity of Dunsfold during the display for reasons of public safety.

In relation to the authority mentioned in regulation 3(2), the Dunsfold air show flying display director may be contacted on telephone number 07711 437499.

Full details of the restricted airspace will be promulgated by Aeronautical Information Circular and NOTAM.
