ROAD TRAFFIC

The A3 Trunk Road (Wisley Interchange – Esher Common Junction) (Temporary Prohibition of Traffic) Order 2013

Made - - - - - *18th March 2013*

Coming into force - - - - - *6th April 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A3 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on lengths of that trunk road and on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A3 Trunk Road (Wisley Interchange – Esher Common Junction) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 6th April 2013.

2. In this Order:

“the A3” means the A3 Trunk Road in the County of Surrey;

“a length of carriageway” means –

- (i) the northbound carriageway of the trunk road between points 400 metres south of the centre of Wisley Interchange (M25 Junction 10) at marker post 13.0 and 300 metres east of the centre of Painshill junction (A3/A245) at marker post 10.2,
- (ii) the northbound carriageway of the trunk road between points 400 metres southwest of the centre of Painshill junction (A3/A245) at marker post 11.1 and 500 metres east of the centre of Esher Common junction (A244) at marker post 5.1,
- (iii) the northbound carriageway of the trunk road between points 500 metres west of the centre of Esher Common junction (A244) at marker post 6.2 and 500 metres east of the centre of Esher Common junction (A244) at marker post 5.1, or
- (iv) the southbound carriageway of the trunk road between points 300 metres east of the centre of Esher Common junction (A244) at marker post 5.3 and 400 metres southwest of the centre of Painshill junction (A3/A245) at marker post 11.1;

“a slip road” means –

- (i) the road leading to the northbound carriageway of the trunk road at Wisley Interchange (M25 Junction 10),
- (ii) the road leading to the northbound carriageway of the trunk road at Painshill junction (A3/A245),

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

- (iii) the road leading to the northbound carriageway of the trunk road at Esher Common junction (A244),
- (iv) the road leading to the southbound carriageway of the trunk road at Esher Common junction (A244),
- (v) the road leading from the southbound carriageway of the trunk road at Esher Common junction (A244), or
- (vi) the road leading to the southbound carriageway of the trunk road at Painshill junction (A3/A245);

“works” mean resurfacing, road marking and road stud installation work on the trunk road;

“a works period” means a period of –

- (i) 7½ hours starting at 2200 hours on Monday 8th April 2013 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2300 hours on Friday 12th April 2013 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 13th April 2013 or on any subsequent Saturday,
- (iv) 7 hours starting at 2230 hours on Sunday 14th April 2013 or on any subsequent Sunday,

until 5th October 2014.

3. Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a length of carriageway or a slip road.

4. The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
