**ROAD TRAFFIC**

**The A52 Trunk Road (Brian Clough Way – Derby Road,  
Nottinghamshire) (Temporary Prohibition of Traffic) Order 2013**

*Made* - - - - - *25th March 2013*

*Coming into force* - - - *1st April 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A52 Trunk Road (“the A52”), is satisfied that traffic on lengths of that road near Bramcote in the County of Nottinghamshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by sections 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as The A52 Trunk Road (Brian Clough Way – Derby Road, Nottinghamshire) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 1st April 2013.

2. In this Order –

| “Bramcote Roundabout” | means the circulatory carriageway of the roundabout junction of the B5010 Derby Road, A6007 Ilkeston Road and Town Street at Bramcote;   |
| “Priory Roundabout”   | means the circulatory carriageway of the roundabout junction of the A6464 Woodside Road and Wollaton Vale near Wollaton Park;  |
| “the trunk road”      | means –<br>(i) the eastbound carriageway of the A52 from its junction with Bramcote Roundabout to its junction with Priory Roundabout; and<br><br>(ii) means the westbound carriageway of the A52 from its junction with Priory Roundabout to its junction with Bramcote Roundabout; |

“the central reservation”	means that part of the trunk road which separates its carriageways for the safety and guidance of vehicular traffic using that road;
"the works period"	means the period starting at 20:00 hours on Sunday 7th April 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the first length of trunk road, the second length of trunk road or Bramcote Roundabout.

4. Subject as mentioned in article 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed through any gap in the central reservation of the trunk road.

5. Subject as mentioned in article 7, no person shall, during the works period, cause or permit any vehicle to enter or leave any side road at its junction with the trunk road.

6. Subject as mentioned in article 7, the provisions of The A52 Trunk Road (Derby Road, Nottingham) (Bus/Cycle Lane) Order 2002 (a) are hereby suspended during the works period on the nearside lane of the eastbound carriageway of the A52 from its junction with Bramcote Roundabout to its junction with Priory Roundabout.

7. The provisions of-

- (1) articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -
  - (i) being used for police, fire brigade or ambulance purposes,
  - (ii) proceeding at the direction of, or with the permission of, a police constable; or
  - (iii) being used in connection with the said works; and
- (2) article 3 shall not apply to any vehicle proceeding in the A52 to or from premises which are accessible for that vehicle from, and only from, that road.
