ROAD TRAFFIC

The A63 Trunk Road (Market Place to Garrison Road Roundabout) (Temporary Prohibition of Traffic and Pedestrians) Order 2013

Made - - - 4th April 2013

Coming into force - 13th April 2013

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A63 Trunk Road and connecting roads, in the District of Kingston upon Hull, is satisfied that traffic and pedestrians on that trunk road and one of those connecting roads should be prohibited because bridge maintenance and repair works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

1. This Order may be cited as the A63 Trunk Road (Market Place to Garrison Road Roundabout) (Temporary Prohibition of Traffic and Pedestrians) Order 2013 and shall come into force on 13th April 2013.

2. In this Order:

"the A63" means the A63 Trunk Road;

"the eastbound carriageway" and "the first length of westbound carriageway" mean, respectively, eastbound and westbound carriageways of the A63 between their junctions with Market Place and their junctions with Garrison Road Roundabout, a distance of 800 metres;

"the second length of westbound carriageway" means the A63 westbound carriageway from the nose of the westbound exit slip road leading to Alexandra Dock to its junction with Garrison Road Roundabout, a distance of 940 metres;

"the slip road" means the A63 westbound entry slip road at Mount Pleasant Roundabout;

"the works period" means a period of 8 hours starting at 06:00 hours on Sunday 14th April 2013 or any subsequent Sunday thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 6 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the eastbound carriageway, first length of westbound carriageway, the second length of westbound carriageway or the slip road.
- **4.** Subject as mentioned in article 6 no person shall, during the works period, cause or permit any vehicle to enter or leave the A63 eastbound carriageway between Market Place and Garrison Road Roundabout, a distance of 800 metres.

- **5.** Subject as mentioned in article 6 no person shall, during the works period, enter or proceed in the A63 between its junction with Market Place and the easternmost limit of Myton Bridge.
- **6.** The provisions of articles 3, 4 and 5 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing article 5 shall apply to any person engaged or assisting in the said works, or anything done at the direction of, or with the permission of, a police officer in uniform.
