**ROAD TRAFFIC**

**The A303 Trunk Road (Podimore Roundabout to Sparkford,  
Somerset) (Temporary Restriction and Prohibition of Traffic)  
Order 2013**

*Made* - - - - *29th May 2013*  
*Coming into force* - - *6th June 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A303 Trunk Road (“the A303”), is satisfied that traffic on a length of that road between Podimore and Sparkford in the County of Somerset should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A303 Trunk Road (Podimore Roundabout to Sparkford, Somerset) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 6th June 2013.

2. In this Order –

“the A303” means the A303 between Podimore and Sparkford from the eastern edge of the A37 Podimore Roundabout to the western edge of the A359 Hazelgrove Roundabout;

“the works” mean carriageway resurfacing;

“a works period” means a period of 10 hours starting at 20.00 hours on Saturday 8th June 2013 or on any subsequent day and ending when the said works have been completed;

“the works period” means the period starting at 00.01 hours on Saturday 8th June 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 6 and 7, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the A303.

4. Subject as mentioned in articles 6, 7 and 8, no person shall, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the A303.

5. Subject as mentioned in articles 6, 7 and 8, no person shall, during a works period, drive any motor vehicle at a speed exceeding 10 miles per hour on the A303 whilst traffic signs of a

character authorised under section 64 of the Road Traffic Regulation Act 1984 indicating “convoy working” on that road are displayed.

**6.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) anything done at the direction of, or with the permission of, a constable.

**7.** The provisions of article 3 shall not apply to:

- (a) a vehicle being used for or in connection with the works or for traffic officer purposes;
- (b) a vehicle proceeding to or from premises that are accessible from and only from the A303.

**8.** No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
