**ROAD TRAFFIC**

**The A23 Trunk Road (Brighton Road, Hooley) (Temporary  
Restriction and Prohibition of Traffic) Order 2013**

*Made* - - - - - *21st January 2013*

*Coming into force* - - - - - *9th February 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A23 Trunk Road, is satisfied that traffic should be restricted and prohibited on a length of that road because works are proposed to be executed near the road:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A23 Trunk Road (Brighton Road, Hooley) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 9th February 2013.

2. In this Order:

“the trunk road” means the A23 Trunk Road (Brighton Road) in the County of Surrey;

“the length of northbound carriageway” means the northbound carriageway of the trunk road between its junction with Netherne Drive and the boundary line of the London Borough of Croydon and Surrey County Council at Hooley;

“the length of southbound carriageway” means the southbound carriageway of the trunk road between the boundary line of the London Borough of Croydon and Surrey County Council and its junction with Netherne Drive at Hooley;

“recovery vehicle” has the meaning given in paragraph 5 of Schedule 1 to the Vehicle Excise and Regulation Act 1994(b);

“overall width” has the meaning given in regulation 3(2) of the Road Vehicles (Construction and Use) Regulation 1986(c);

“works” mean TfL resurfacing work near the trunk road; and

“a works period” means a period of

- (i) 7½ hours starting at 2200 hours on Monday 11th February 2013 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2300 hours on Friday 15th February 2013 or on any subsequent Friday,

- (iii) 8 hours starting at 2200 hours on Saturday 16th February 2013 or on any subsequent Saturday, or
- (iv) 7 hours starting at 2230 hours on Sunday 17th February 2013 or on any subsequent Sunday,

until 8th August 2014.

**3.** Subject as mentioned in articles 5 and 6 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the length of northbound carriageway.

**4.** During such times as, pursuant to article 5, movement of traffic is prohibited in the northbound carriageway but is not prohibited in any lane of the length of southbound carriageway.

**5.** The provisions of articles 3 and 4 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs.

**6.** (1) Nothing in article 3 above shall apply to -

- (a) a recovery vehicle or a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
