**The A50 Trunk Road (Foston to Sudbury, Derbyshire)
(Temporary Restriction and Prohibition of Traffic) Order 2013**

Made - - - - *3rd June 2013*
Coming into force - - *10th June 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road (“the A50”) and connecting roads, is satisfied that traffic on lengths of that road and on one of those connecting roads between Foston and Sudbury in the County of Derbyshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a), (5)(b) and (7) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A50 Trunk Road (Foston to Sudbury, Derbyshire) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 10th June 2013.

2. In this Order:

“the first length of trunk road” means the westbound carriageway of the A50 from a point 1000 metres east of its junction with the exit slip road leading to the roundabout junction with the A511, to its junction with that slip road;

“the second length of trunk road” means the westbound carriageway of the A50 from its junction with the exit slip road leading to its roundabout junction with the A511, to its roundabout junction with the A515 and Aston Lane at Sudbury;

“the third length of trunk road” means the eastbound carriageway of the A50 from its roundabout junction with the A515 and Aston Lane at Sudbury, to its junction with the entry slip road leading from its roundabout junction with the A511 and Packenham Boulevard, east of Foston;

“the slip road” means the slip road leading to the westbound carriageway of the A50 from its junction with the A511 east of Foston;

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

- i) the slip road leading to the eastbound carriageway of the A50 from Uttoxeter Road, Foston;

“the works period”

means the period starting at 20:00 hours on Thursday 13th June 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 6 and 7, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour in the first length of trunk road.

4. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the second length of trunk road or a slip road.

5. Subject as in article 6 and 7, no person shall, during the works period, enter the third length of trunk road at its junction with Uttoxeter Road, Foston.

6. The provisions of article 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

7. The provisions of –

(a) articles 3 and 4 shall not apply to any vehicle -

(i) being used for police, fire brigade or ambulance purposes; or

(ii) proceeding at the direction of, or with the permission of, a police constable;

(b) article 3 shall not apply to any vehicle being used for special forces purposes; and

(c) articles 4 and 5 shall not apply to any vehicle being used in connection with the said works.

(d) article 4 shall not apply to any vehicle proceeding in the second length of trunk road or the third length of trunk road to or from premises which are accessible for that vehicle from, and only from, that road.
