**ROAD TRAFFIC**

**The A14 Trunk Road (Naseby to Rothwell, Northamptonshire)  
(Temporary Prohibition of Traffic) Order 2013**

*Made* - - - - *1st July 2013*  
*Coming into force* - - *8th July 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A14 Trunk Road (“the A14”) and connecting roads, is satisfied that traffic on lengths of that road and six of those connecting roads, between Naseby and Rothwell in the County of Northamptonshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A14 Trunk Road (Naseby to Rothwell, Northamptonshire) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 8th July 2013.

2. In this Order:

“the trunk road” means –

- i) the eastbound carriageway of the A14 from its junction with the exit slip road leading to the A508 near Kelmarsh to its junction with the entry slip road leading from its roundabout junction with the A6 and the B576 near Rothwell;
- ii) the westbound carriageway of the A14 from its junction with the exit slip road leading to its roundabout junction with the A6 near Rothwell to its junction with the entry slip road leading from the A508 near Kelmarsh; and
- iii) the westbound carriageway of the A14 from its junction with exit slip road leading to the A508 near Kelmarsh to its junction with the entry slip road leading from the A5199 west of Naseby;

“a slip road” means the slip road leading –

- i) to the eastbound carriageway of the of the A14 from its junction with the A508 near Kelmarsh;

- ii) from the eastbound carriageway of the of the A14 to its roundabout junction with the A6 and B576 near Rothwell;
- iii) to the westbound carriageway of the A14 from its roundabout junction with the A6 near Rothwell;
- iv) to the westbound carriageway of the A14 from its junction with the A508 near Kelmarsh;
- v) from the westbound carriageway of the A14 to its junction with the A508 near Kelmarsh; and
- vi) from the westbound carriageway of the A14 to its junction with the A5199 west of Naseby;

“layby” means an area of carriageway intended for the waiting of vehicles and bounded partly by a traffic sign of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(a) and partly by the outer edge of that carriageway on the same side of the road as that on which the sign is placed; and in this definition “carriageway” means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

“the works period” means the period starting at 00:01 hours on Sunday 14th July 2013 and ending when the said works have been completed,

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.

**4.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any layby adjacent to the trunk road.

**5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle-

- (i) being used for police, fire brigade or ambulance purposes;
- (ii) proceeding at the direction of, or with the permission of, a police constable; or
- (iii) being used in connection with the said works.
