## ROAD TRAFFIC

The A1 Trunk Road (Barnsdale Bar Interchange to Redhouse Interchange) (Temporary Prohibition of Traffic) Order 2013

 Made
 11th July 2013

 Coming into force
 21st July 2013

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1 Trunk Road, the A1(M) Motorway and connecting roads, in the District of Doncaster, in the County of South Yorkshire, is satisfied that traffic on that trunk road, that motorway and some of those connecting roads should be prohibited because carriageway resurfacing and safety barrier installation works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

**1.** This Order may be cited as the A1 Trunk Road (Barnsdale Bar Interchange to Redhouse Interchange) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 21st July 2013.

## 2. In this Order; -

"the A1" means the A1 Trunk Road:

"the southbound carriageway" means the A1 and the A1(M) Motorway southbound carriageways from the nose of the southbound exit slip road at the A639 Barnsdale Bar Interchange to the nose of the southbound entry slip road at Junction 38 (Redhouse), a distance of 6600 metres;

"a slip road" means the A1 southbound entry slip road at Barnsdale Bar Interchange and the southbound exit slip road at Redhouse Interchange;

"the works period" means a period of 10 hours starting at 20:00 hours on Tuesday 21st July 2013 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the southbound carriageway or a slip road.
- **4.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or leave the A1 at its junctions with the B1220 Hampole Balk Lane.

- **5.** The provisions of article 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
  - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
  - (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
