**ROAD TRAFFIC**

**The A1 Trunk Road (Leeming to Catterick) (Prohibition of Use of Gaps in the Central Reservation) (Experimental) Order 2013**

*Made* - - - - *25th January 2013*

*Coming into force* - - *8th February 2013*

The Secretary of State for Transport makes the following Order in exercise of the powers conferred by sections 9(1)(a) and (3) and 10(1) and (2) of the Road Traffic Regulation Act 1984(a):

1. This Order may be cited as the A1 Trunk Road (Leeming to Catterick) (Prohibition of Use of Gaps in the Central Reservation) (Experimental) Order 2013 and shall come into force 8th February 2013.

2. In this Order; –

“the A1” means the A1 Trunk Road in the Districts of Hambleton and Richmondshire, in the County of North Yorkshire;

“the central reservation” means that part of the A1 which separates its carriageways for the safety and guidance of traffic using that road;

3. No person shall cause or permit any vehicle to enter or proceed through a gap in the central reservation as specified in the Schedule to this Order.

4. If it appears to the Director of Network Delivery and Development (Yorkshire and North East) of the Highways Agency essential in the interests of the expeditious, convenient and safe movement of traffic, they may after:

- (a) consulting with the Chief Constable for North Yorkshire, and
- (b) giving such public notice as the Secretary of State may direct,

modify or suspend the operation of this Order or any of its provisions.

The gaps in the central reservation situated opposite the junction of the A1 with:

- (i) Little Holtby access road;
- (ii) Holtby Hall access road;
- (iii) Angleham House access road;
- (iv) Tickergate Lane;
- (v) Bowbridge Lane;
- (vi) Dere Street Farm access road;
- (vii) Lords Lane;
- (viii) Low Street;
- (ix) Sowber Hill Farm / Killerby Lodge access road;
- (x) Killerby Farm access road;
- (xi) Leases Lane;
- (xii) Lime Kiln Farm access;
- (xiii) Home Farm access;
- (xiv) York House access;
- (xv) North Lodge access; and
- (xvi) Oak Grange access

This Order closes the gaps in the central reservation of the A1 Trunk Road from Leeming to north of Catterick as described in the Schedule to the Order.
