ROAD TRAFFIC

The A303 Trunk Road (Near Hindon, Wiltshire) (Temporary Restriction and Prohibition of Traffic) (Number 2) Order 2013

Made - - - - *30th August 2013*

Coming into force - - *6th September 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A303 Trunk Road (“the A303”), is satisfied that traffic on a length of that road near Hindon in Wiltshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:

1. This Order may be cited as the A303 Trunk Road (Near Hindon, Wiltshire) (Temporary Restriction and Prohibition of Traffic) (Number 2) Order 2013 and shall come into force on 6th September 2013.

2. In this Order –

“the A303” means the A303 near Hindon from a point at the centre of its junction with the A350 to a point at the centre of its junction with the B3089 at Willoughby Hedge;

“the works” mean resurfacing, edge and road markings;

“a works period” means a period of 10 hours starting at 20.00 hours on Wednesday 11th September 2013 or on any subsequent day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to an article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during a works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the A303.

4. Subject as mentioned in article 5, no person shall, during a works period, drive any motor vehicle at a speed exceeding 10 miles per hour on the A303 whilst traffic signs of a character authorised under section 64 of the Road Traffic Regulation Act 1984 indicating “convoy working” on that road are displayed.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

(a) a vehicle being used for police, fire and rescue authority or ambulance purposes; or

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

(b) anything done at the direction of, or with the permission of, a constable.

6. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
