**ROAD TRAFFIC**

**The A43 Trunk Road (Silverstone,  
Northamptonshire)(Temporary 50 Miles Per Hour Speed  
Restriction)Order 2013**

*Made* - - - - *16th August 2013*

*Coming into force* - - *23rd August 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A43 Trunk Road (“the A43”) and connecting roads, is satisfied that traffic on lengths of that road and some of those connecting roads near Silverstone in the County of Northamptonshire should be restricted because of the likelihood of danger to the public:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(b) of the Road Traffic Regulation Act 1984 (a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A43 Trunk Road (Silverstone, Northamptonshire) (Temporary 50 Miles Per Hour Speed Restriction) Order 2013 and shall come into force on 23rd August 2013.

2. Subject as mentioned in article 3 below, no person shall, during the period starting at 00.01 hours on Friday 30th August 2013 and ending when the said likelihood of danger has been avoided by means other than this order, drive any motor vehicle at a speed exceeding 50 miles per hour on –

- (a) the northbound carriageway of the A43 from a point 1300 metres south of its junction with the slip road leading to the A413 Brackley Road, southwest of Silverstone, to a point 350 metres north of its junction with the slip road leading from the A413 Towcester Road, northeast of Silverstone;
- (b) the southbound carriageway of the A43 from a point 1200 metres north of its junction with the slip road leading to the A413, northeast of Silverstone to a point 2700 metres south of its junction with the slip road leading from the A413 Dadford Road, southwest of Silverstone;
- (c) the slip road leading from the northbound carriageway of the A43 to the A413 Brackley Road;
- (d) the slip road leading to the northbound carriageway of the A43 from the A413 Dadford Road;

- (e) the slip road leading to the northbound carriageway of the A43 from its roundabout junction with the A413 Towcester Road;
- (f) the slip road leading from the southbound carriageway of the A43 to its roundabout junction with the A413;
- (g) the slip road leading from the southbound carriageway of the A43 to Dadford Road; and
- (h) the slip road leading to the southbound carriageway of the A43 from Dadford Road.

**3.** The provisions of article 2 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to any vehicle –

- (a) being used for police, fire brigade, ambulance or special forces purposes; or
- (b) proceeding at the direction of, or with the permission of, a police constable.
