ROAD TRAFFIC

**The A417 Trunk Road (Shurdington Road Roundabout to Air
Balloon Roundabout, Gloucestershire)
(Temporary Prohibition of Traffic) Order 2013**

Made - - - - *17th September 2013*

Coming into force - - *23rd September 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A417 Trunk Road (“the A417”) and connecting roads, is satisfied that traffic on a length of that road and some of those connecting roads in the District of Tewkesbury in the County of Gloucestershire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A417 Trunk Road (Shurdington Road Roundabout to Air Balloon Roundabout, Gloucestershire) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 23rd September 2013.

2. In this Order –

“the A417” means (i) the A417 southbound carriageway from the tip of the nosing of the southbound exit slip road at the A46 Shurdington Road Roundabout to the eastern edge of the Air Balloon Roundabout, near Cheltenham; and (ii) the A417 northbound carriageway from the southern edge of the Air Balloon Roundabout, near Cheltenham to the tip of the nosing of the northbound exit slip road at the A46 Shurdington Road Roundabout;

“the slip roads” mean (i) the A417 southbound entry slip road at the A46 Shurdington Road Roundabout and (ii) the A417 northbound exit slip road at the A46 Shurdington Road Roundabout

“the tip of the nosing” means the first point where an entry slip road joins the carriageway of a trunk road or the last point where an exit slip road leaves the carriageway of a trunk road;

“the works” mean routine maintenance works including surfacing, studding, white lining and routine maintenance;

“a works period” means a period of 10 hours starting at 20.00 hours on Wednesday 25th September 2013 or on any subsequent day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the A417 and the slip roads.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to a vehicle being used in connection with the said works.
