**The Armed Forces Act 2011  
(Commencement No. 4) Order 2013**

*Made - - - - 26th September 2013*

The Secretary of State makes the following Order in exercise of the powers conferred by section 32(3) of the Armed Forces Act 2011<sup>(1)</sup>:

**Citation and interpretation**

1. This order may be cited as the Armed Forces Act 2011 (Commencement No. 4) Order 2013.
2. In this Order “the Act” means the Armed Forces Act 2011.

**Commencement**

3. The following provisions of the Act shall come into force on 1st November 2013—
  - (a) section 9;
  - (b) sections 10 and 11 so far as not already in force;
  - (c) section 16(1);
  - (d) section 30(1) so far as is necessary to bring into force paragraphs 3(1), (2) and (4), 4, 8, 10, 11, 12 and 13 of Schedule 4;
  - (e) section 30(2) so far as is necessary to bring into force the entries in Schedule 5 relating to sections 305, 306, 307 and 308 of the Armed Forces Act 2006<sup>(2)</sup>.
