## ROAD TRAFFIC

The A46 Trunk Road (Thorpe on the Hill, Lincolnshire) (Temporary Restriction and Prohibition of Traffic) Order 2013

Made - - - - 7th October 2013

Coming into force - - 14th October 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A46 Trunk Road ("the A46"), is satisfied that traffic on lengths of that road, near Thorpe on the Hill in the County of Lincolnshire, should be prohibited and restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

- **1.** This Order may be cited as the A46 Trunk Road (Thorpe on the Hill, Lincolnshire) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 14th October 2013.
  - 2. In this Order –

"the first length of trunk road" means –

- i) the northbound carriageway of the A46 from its roundabout junction with Halfway House Lane (Halfway House Roundabout) at Witham St Hughs to its junction with Moor Lane, near Thorpe on the Hill; and
- ii) the southbound carriageway of the A46 from its junction with Moor Lane, near Thorpe on the Hill to its junction with Haddington Lane, near Haddington;

"the second length of trunk road" means –

i) the northbound and southbound carriageways of the A46 from the junction with Moor Lane, near Thorpe on the Hill to the junction with Haddington Lane, near Haddington; and ii) the southbound carriageway of the A46 from its roundabout junction with the B1190, Doddington Road and Lincoln Road, near Birchwood to its junction with Moor Lane, near Thorpe on the Hill:

"layby"

means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(a) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

"bus stop area"

means any area of a carriageway on a side of the trunk road, intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagram 1025, 1025.1, 1025.3 or 1025.4 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;

"the works period"

means the period starting at 20:00 hours on Monday 21st October 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 8 and 9, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the first length of trunk road.
- **4.** Subject as mentioned in articles 8 and 9, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the second length of trunk road.
- **5.** Subject as mentioned in articles 8 and 9, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the layby situated adjacent to
  - the southbound carriageway of the A46 approximately 440 metres south of its roundabout junction with the A1434 and Middle Lane (Hykeham Roundabout); and
  - ii) the northbound carriageway of the A46 approximately 190 metres north of its roundabout junction with the A1434 and Middle Lane (Hykeham Roundabout).
  - **6.** Subject as mentioned in articles 8 and 9, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the bus stop area situated adjacent to the northbound carriageway of the A46 approximately 300 metres north of its junction with Haddington Lane, near Haddington.
  - 7. Subject as mentioned in articles 8 and 9, no person shall, during the works period, cause or permit any vehicle to enter or leave -

- i) the A46 at its junction with the access road leading to and from Thorpe Grange Farm, north of Haddington;
- ii) Hykeham Roundabout at its junction with the A1434; or
- iii) Hykeham Roundabout at its junction with Middle Lane.
- **8.** The provisions of articles 3, 4, 5, 6 and 7 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - 9. The provisions of -
  - a) article 3 shall not apply to any vehicle being used for special forces purposes;
  - b) articles 3, 4, 5, 6 and 7 shall not apply to any vehicle -
    - (i) being used for police, fire brigade or ambulance purposes; or
    - (ii) proceeding at the direction of, or with the permission of, a police constable; and
  - c) articles 4, 5, 6 and 7 shall not apply to any vehicle being used in connection with the said works.
