ROAD TRAFFIC

The A500 Trunk Road (Sideway, Stoke-on-Trent) (Temporary Prohibition of Traffic) Order 2013

Made - - - - 13th February 2013

Coming into force - - 20th February 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A500 Trunk Road ("the A500") and connecting roads, is satisfied that traffic on a length of that trunk road and some of those connecting roads, at Sideway in the City of Stoke-on-Trent should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A500 Trunk Road (Sideway, Stoke-on-Trent) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 20th February 2013.

2. In this Order:

"Sideway Roundabout"

means the circulatory carriageway of the A500 at its roundabout junction with the A50 at Sideway;

"the trunk road"

means -

- (i) the northbound carriageway of the A500 from its junction with exit slip leading to the A5006 and A50 to its junction with the entry slip road leading from Sideway Roundabout;
- (ii) the southbound carriageway of the A500 from its junction with the exit slip road leading to Sideway Roundabout to its junction with the entry slip road leading from the A5006 and A50; and
- (iii) the southern section of Sideway Roundabout between its junction with the slip road leading to the southbound carriageway of the A500 and the

slip road leading from the northbound carriageway of the A500;

"a slip road"

means the slip road leading -

- (i) to the northbound carriageway of the A500 from its roundabout junction with the A34 Stone Road at Hanford:
- (ii) from the northbound carriageway of the A500 to the A5006;
- (iii) to the northbound carriageway of the A500 from the A5006;
- (iv) from the southbound carriageway of the A500 to Sideway Roundabout and A50;
- (v) to the southbound carriageway of the A500 from A5006;
- (vi) from Sideway Roundabout to the southbound carriageway of the A500 and to its roundabout junction with the A5006; and
- (vii) from the northbound carriageway of the A500 to Sideway Roundabout;

"the works period"

means the period starting at 21.00 hours on Wednesday 27th February 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - 5. The provisions of article 3 shall not apply to any vehicle-
 - (i) being used for police, fire brigade or ambulance purposes,
 - (ii) proceeding at the direction of, or with the permission of, a police constable, or
 - (iii) being used in connection with the said works.
