# The Air Navigation (Restriction of Flying) (Mortlake) Regulations 2013

 Made
 16th April 2013

 Coming into force
 17th April 2013

The Secretary of State deems it necessary in the public interest to restrict flying in the vicinity of Mortlake Crematorium, Richmond, Greater London, by reason of the cremation of Baroness Thatcher that is scheduled to take place on 17th April 2013.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Mortlake) Regulations 2013 and come into force on 17th April 2013.

### **Interpretation**

**2.** In regulation 3 all times referred to are Co-ordinated Universal Time.

## Restricted airspace

- **3.**—(1) Subject to paragraph (2), between 1400 hours and 1630 hours on 17th April 2013, no aircraft is to fly below 2,500 feet above mean sea level within the area bounded by a circle having a radius of 2.5 nautical miles whose centre is at 512822N 0001623W.
  - (2) Paragraph (1) does not apply to any aircraft—
    - (a) making an approach to, or departing from—
      - (i) London City Airport,
      - (ii) London Heathrow Airport, or
      - (iii) RAF Northolt,

whilst under the control of either the London Terminal Control Centre at Swanwick or RAF Northolt Approach,

- (b) operated by the Metropolitan Police Service,
- (c) flying in the service of the Helicopter Emergency Medical Services, or
- (d) flying in accordance with the permission of the Secretary of State.

## **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations restrict flying in the vicinity of, Richmond, Greater London on the day of the cremation of Baroness Thatcher, which is scheduled to take place at Mortlake Crematorium on 17th April 2013. These restrictions form part of the overall safety and security arrangements for this event and have been agreed with the Civil Aviation Authority and the Department for Transport.
