ROAD TRAFFIC

**The M60 Motorway (Junction 13 Clockwise Entry Slip Road)
and M62 (Junction 12 Eastbound Link Road to the M60
Clockwise) (Temporary Prohibition of Traffic) Order 2014**

Made - - - - *28th August 2014*

Coming into force - - *14th September 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M60 and M62 Motorways and their slip and link roads, is satisfied that traffic on one of those slip roads and one of those link roads in the District of Salford in Greater Manchester should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984 (a), hereby makes the following Order:-

1. This Order may be cited as the M60 Motorway (Junction 13 Clockwise Entry Slip Road) and M62 (Junction 12 Eastbound Link Road to the M60 Clockwise) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 14th September 2014.

2. In this Order:

“the motorway” means the M60 Motorway;

“works” means resurfacing, road renewal and maintenance works;

“the works period” means period overnight between 2300 hours and 0500 hours during a period starting on Monday 15th September 2014 and ending on Friday 19th September 2014. However, work may start and continue between the same times on subsequent nights or continue until completed, for such period not exceeding 18 months as shall be required to complete the work;

“the slip road” means the entry slip road leading to the clockwise carriageway of the motorway at Junction 13;

“the link road” means the link road leading from the eastbound carriageway of the M62 Motorway at Junction 12 to the clockwise carriageway of the motorway.

3. Subject as mentioned in article 4 of this Order, during the works period, no person shall cause or permit any vehicle to enter or proceed in the slip road or the link road.

4. The provisions of article 3 of this Order shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle being used for emergency purposes by the police, fire and rescue or ambulance services, vehicles being used in connection with the works, or to any vehicle proceeding at the direction, or with the permission, of a constable, or a traffic officer in uniform.
