**The Meaford Gas Fired Generating
Station (Correction) Order 2016**

Made - - - - *1st November 2016*
22nd November
Coming into force - - *2016*

The Meaford Gas Fired Generating Station Order 2016 (“the Order”)(1), which granted development consent within the meaning of the Planning Act 2008 (“the Act”)(2), contains correctable errors within the meaning of the Act(3).

Before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(4) for the correction of errors and omissions in the Order under paragraph 1(5)(a) of Schedule 4 to the Act .

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed Stafford Borough Council and Staffordshire County Council that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraphs 1(4) and (8) of Schedule 4 to, the Act, makes the following Order:

Citation and commencement

1. This Order may be cited as the Meaford Gas Fired Generating Station (Correction) Order 2016 and comes into force on 22nd November 2016.

Corrections

2. The Meaford Gas Fired Generating Station Order 2016 is corrected as set out in the table in the Schedule to this Order, where—

- (a) column 1 sets out where the correction is to be made;
- (b) column 2 sets out how the correction is to be made; and
- (c) column 3 sets out the text to be substituted, inserted or omitted.
