The Air Navigation (Restriction of Flying) (Portsmouth to Southampton Airport) Regulations 2019

Made - - - - - *30th May 2019*

Coming into force - - - - - *5th June 2019*

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of a route between Portsmouth, Hampshire, and Southampton Airport, Hampshire, by reason of the intended visit by a Head of State.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016^(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Portsmouth to Southampton Airport) Regulations 2019 and come into force on 5th June 2019.

Interpretation

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time^(b).

Restricted airspace

3.—(1) Subject to paragraph (2), between 1300 hours and 1415 hours on 5th June 2019, no aircraft is to fly below 3,000 feet above mean sea level within the area bounded by—

- (a) straight lines joining successively the following points—
 - (i) 504952N 0011702W,
 - (ii) 510130N 0011058W,
 - (iii) 505445N 0010338W, and
- (b) the anti-clockwise arc of a circle having a radius of 8 nautical miles centred on 504650N 0010521W, from 505445N 0010338W to 504952N 0011702W.

(2) Paragraph (1) does not apply to any aircraft—

- (a) making an approach to, or departing from, Southampton Airport whilst under the control of the air traffic control unit at Southampton Airport, or
- (b) operated by or on behalf of—

(a) S.I. 2016/765 to which there are amendments not relevant to these Regulations.

(b) In these Regulations, Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

- (i) the National Police Air Service,
 - (ii) the Helicopter Emergency Medical Services,
 - (iii) the Maritime and Coastguard Agency, or
 - (iv) The Queen's Helicopter Flight, or
- (c) operated with the permission of the Metropolitan Police Service.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations restrict flying in a corridor between Portsmouth, Hampshire, and Southampton Airport, Hampshire on the occasion of a visit by a Head of State which is scheduled to take place on 5th June 2019.

As part of the overall security arrangements for the visit, the Metropolitan Police considers it is in the public interest that flying should be restricted along a route between Portsmouth, Hampshire, and Southampton Airport, Hampshire for reasons of public safety and security. This has been agreed with the Civil Aviation Authority and the Department for Transport.

In relation to regulation 3, the term 'aircraft' includes aircraft as classified by Part 1 of Schedule 4 to the Air Navigation Order 2016. It also includes, by virtue of article 23 of that Order, any small balloon, any kite weighing not more than two kilograms, any small unmanned aircraft and any parachute including a parascending parachute.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC), which for the purpose of these Regulations is one hour behind British Summer Time (BST).
