LOCAL GOVERNMENT, ENGLAND

The Vale of White Horse (Electoral Changes) Order 2019

*Made - - - - 20th February 2019
Coming into force in accordance with article 1(2), (3)
and (4)*

Under section 92(2) of the Local Government and Public Involvement in Health Act 2007⁽¹⁾, the Vale of White Horse District Council (“the Council”) made recommendations in a review to the Local Government Boundary Commission for England⁽²⁾ for the related alteration of the boundaries of district wards and county electoral divisions within the Council’s area.

The Local Government Boundary Commission for England has decided to give effect to the recommendations and makes the following Order in exercise of the power conferred by section 92(3) of that Act.

Citation and commencement

- 1.—(1) This Order may be cited as the Vale of White Horse (Electoral Changes) Order 2019.
- (2) This article and article 2 come into force on the day after the day on which this Order is made.
- (3) Article 3 comes into force—
 - (a) for the purpose of proceedings preliminary or relating to the election of councillors, on the day after the day on which this Order is made;
 - (b) for all other purposes, on the ordinary day of election of councillors in England⁽³⁾ in 2019.
- (4) Article 4 comes into force—
 - (a) for the purpose of proceedings preliminary or relating to the election of councillors, on the day after the day on which this Order is made;
 - (b) for all other purposes, on the ordinary day of election of councillors in England in 2021.

(2) The Local Government Boundary Commission for England was established on 1st April 2010 by section 55(1) of the 2009 Act. The functions of the Electoral Commission under Chapter 3 of Part 4 of the Local Government and Public Involvement in Health Act 2007 (c. 28) (“the 2007 Act”) were transferred under section 60 of the 2009 Act to the Local Government Boundary Commission for England on 1st April 2010.

(3) The ordinary day of election of councillors in England is prescribed by section 37(1) of the Representation of the People Act 1983 (c. 2), as amended by section 18(2) of the Representation of the People Act 1985 (c. 50) and section 6(16) of the Wales Act 2017 (c. 4).

Interpretation

2.—(1) In this Order—

“the 2018 Order” means the Vale of White Horse District Council (Reorganisation of Community Governance) Order 2018(4);

“the map” means the map marked “Map referred to in the Vale of White Horse District Council (Reorganisation of Community Governance) Order 2018”, held by the Vale of White Horse District Council(5).

(2) Where a boundary is shown on the map as running along a road, railway line, footway, watercourse or similar geographical feature, it is to be treated as running along the centre line of the feature.

Alteration of district ward boundaries

3.—(1) The area that ceases to be part of the parish of Fyfield & Tubney and becomes part of the parish of Kingston Bagpuize with Southmoor in consequence of the Vale of White Horse District Council (Reorganisation of Community Governance) Order 2015(6), ceases to be part of the Thames district ward and becomes part of the Kingston Bagpuize district ward.

(2) Each area described in the first column of the table in Schedule 1 ceases to be part of the district ward listed in the corresponding entry in the second column of that table and becomes part of the district ward listed in the corresponding entry in the third column of that table.

Alteration of county electoral division boundaries

4. Each area described in the first column of the table in Schedule 2 ceases to be part of the electoral division listed in the corresponding entry in the second column of that table and becomes part of the electoral division listed in the corresponding entry in the third column of that table.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect to recommendations made by Vale of White Horse District Council to the Local Government Boundary Commission for England for related alterations of district ward and county electoral division boundaries.

These alterations are a consequence of changes to certain parish boundaries introduced by the Vale of White Horse District Council (Reorganisation of Community Governance) Order 2015 (accessible at <http://www.whitehorsedc.gov.uk/services-and-advice/local-democracy/town-and-parish-councils/local-government-and-public-involveme-1>) and the Vale of White Horse District Council (Reorganisation of Community Governance) Order 2018 (accessible at [http://s3-eu-west-2.amazonaws.com/lgbce/Reviews/South%20East/Oxfordshire/Vale%20of%20White%20Horse/CGR/The%20Vale%20of%20White%20Horse%20DC%20\(ROCG\)%20Order%202018.pdf](http://s3-eu-west-2.amazonaws.com/lgbce/Reviews/South%20East/Oxfordshire/Vale%20of%20White%20Horse/CGR/The%20Vale%20of%20White%20Horse%20DC%20(ROCG)%20Order%202018.pdf)). The changes to county electoral division boundaries under article 4 apply in respect of elections to be held on and after the ordinary day of election of councillors in England in 2021.
