Monsieur le Ministre.

Copenhagen, September 26, 1955.

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Denmark concerning compulsory military service in the armed forces of both countries signed at London on the 20th day of January, 1955.⁽¹⁾

The Government of the United Kingdom now propose that the provisions of this Agreement shall be extended, in accordance with Article II thereof, to persons who are or may become liable to perform compulsory military service both under the law with regard to such service in any of the Channel Islands or the Isle of Man and under that in force with regard to such service in Denmark.

If the foregoing proposal is acceptable to the Danish Government I have the honour to suggest that this Note together with your Excellency's reply in that sense shall be regarded as constituting an agreement between the two Governments in this matter.
