Your Excellency,

Ankara, May 29, 1963.

I have the honour to refer to the Agreement constituted by the Exchange of Notes of the 1st of March, 1960,⁽¹⁾ between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Turkey concerning the reciprocal abolition of visas for British subjects and British protected persons travelling to Turkey and for Turkish citizens travelling to the United Kingdom of Great Britain and Northern Ireland, the Channel Islands, the Isle of Man and certain British oversea dependent territories.

The Territory of the New Hebrides which is in fact an Anglo-French Condominium was included in error in the British oversea dependent territories listed in the Annex to my Note of the 1st of March, 1960. I have therefore to suggest, on the instructions of Her Majesty's Principal Secretary of State for Foreign Affairs, that the New Hebrides should be deleted from the list of British territories to which the above Agreement applies. If this proposal is acceptable to the Government of the Republic of Turkey, I have the honour to propose that the present Note and Your Excellency's reply to that effect shall place on record the agreement of the two Governments in this matter.
