British Embassy,

Your Excellency,

San Salvador, 3 July, 1968.

I have the honour to refer to this Embassy's Note No. 16 of the 4th of June 1968 which informed Your Excellency that the authorities of the Isle of Man have decided to issue their own passports.

2. The Government of the United Kingdom wish to apply to the holders of the said passports the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of El Salvador for the Abolition of Visas constituted by the Exchange of Notes of the 20th of August 1962.(¹)

3. I now have the honour to propose, on the instructions of Her Majesty's Principal Secretary of State for Foreign Affairs, that the words "or Isle of Man" be inserted after the words "Guernsey or its Dependencies" in sub-paragraph (b) of the said Agreement.

4. If the foregoing proposal is acceptable to the Government of El Salvador, I have the honour to suggest that this Note together with Your Excellency's reply to that effect shall constitute an Agreement between the two Governments in this matter.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest esteem and consideration.

Tengo el honor de acusar recibo de la atenta nota de Vuestra Excelencia No. 18, de fecha 3 del corriente, que dice:

"Excelencia: Tengo el honor de dirigirme a Ud. para referirme a la Nota No. 16 del 4 de junio del corriente año, en la cual se informó

a Su Excelencia, la decisión de las autoridades de la Isla de Man, de emitir sus propios pasaportes. El Gobierno del Reino Unido desea que se apliquen a los poseedores de dichos pasaportes las regulaciones del Acuerdo entre el Gobierno del Reino Unido e Irlanda del Norte y el Gobierno de El Salvador para la Abolición de Visas, establecido por el Intercambio de Notas del 20 de agosto de 1962. Por instrucciones del Secretario Principal del Estado para Asuntos Extranjeros de Su Majestad, tengo el honor ahora, de proponer que las palabras "or Isle of Man" sean intercaladas después de las palabras "Guernsey or its Dependencies" en el sub-párrafo (b) de dicho Acuerdo. Si la anterior propuesta es aceptable al Gobierno de El Salvador, tengo el honor de sugerir que esta Nota juntamente con la respuesta de Su Excelencia a ese efecto, constituirá un Acuerdo entre los dos Gobiernos sobre este asunto. Aprovecho esta oportunidad para reiterar a Vuestra Excelencia las seguridades de mi más alta y distinguida consideración.
