BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM

Sir

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Union of South Africa of 26 October 1945 on the establishment of Civil Air Services between our two countries(1) and, in accordance with the discussions which took place in London on 19-21 September 1972, have the honour to propose that:

- 1. The following routes shall be exchanged:
- (a) For British Overseas Airways Corporation (BOAC)
 - (i) Regional Routes Seychelles-Johannesburg and/or Durban (in either order)
 - (ii) Trunk Routes
 Hong Kong-intermediate points-Seychelles-Johannesburg
- (b) For South African Airways (SAA)
 - (i) Regional Routes
 Johannesburg and/or Durban (in either order)-Seychelles
 - (ii) Trunk Routes
 Johannesburg-Seychelles-intermediate points-Hong Kong-Tokyo

Both airlines may for economic and operational reasons combine the operation of air services on the regional and trunk routes. Any point or points may be omitted provided the services start at a point on the route in the national territory of the airline of the Contracting Party.

- 2. The following traffic rights may be exercised by the airlines of the Contracting Parties:
 - (i) By BOAC
 Between all points on the routes and Durban and Johannesburg
 - (ii) By SAA

 Between all points on the routes and Durban and Johannesburg and fifth freedom rights between all intermediate points on the routes

and Seychelles. No traffic may be carried between the Seychelles and Hong Kong or vice versa which originates in or is destined for either point.

- 3. The air services operated in terms of this Agreement will be subject to the relevant terms and conditions set out in the 1945 Agreement referred to above.
- 4. Durban or Cape Town will be available in addition to or instead of Johannesburg as terminals on the route for both of the Contracting Parties set out in paragraph 2 of the Annex to the Agreement of 26 October 1945 under provisions determined between SAA and BOAC, subject to the approval of the Contracting Parties in accordance with that Agreement and Annex.

If the above proposals are acceptable to the Government of the Republic of South Africa I have the honour to propose that this Note and your reply to that effect shall be regarded as constituting an Agreement between our two Governments in this matter which shall enter into force on this day's date.
