Your Excellency,

*27 June, 1973.*

I have the honour to refer to the Ethiopia/United Kingdom Civil Aviation Loan Agreement, 1972, constituted by the Exchange of Notes dated 21 March 1972 between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Empire of Ethiopia,<sup>(1)</sup> and to propose that the Agreement be amended as follows:

Paragraph 3 (a) (iii): the date " 30 April 1973 " shall be deleted and replaced by the date " 30 April 1974 ".

If the foregoing proposal is acceptable to the Government of the Empire of Ethiopia, I have the honour to suggest that the present Note together with Your Excellency's reply in that sense shall constitute an agreement between our two Governments to amend the Ethiopia/United Kingdom Civil Aviation Loan Agreement, 1972, which shall enter into force on the date of your reply.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
