I have the honour to refer to the recent exchange of correspondence between Your Excellency and the Prime Minister of the United Kingdom about the termination of the Agreement between Her Majesty's Government in the United Kingdom of Great Britain and Northern Ireland and the Government of the Maldives Islands, signed on 26 July 1965.⁽¹⁾

I have the honour to propose that the present Note and your reply confirming that the Government of the Republic of Maldives agree that the above-mentioned Agreement be terminated with effect from 29 March 1976 shall constitute an agreement between the two Governments terminating the above-mentioned Agreement with effect from 29 March 1976.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
