Sir,

I have the honour to refer to the Overseas Service (Lesotho) (Continuance) Agreement 1971/76⁽¹⁾ (hereinafter referred to as "the Agreement") and to propose that the Agreement be amended as follows:—

- (a) Sub-paragraph 5 (d) of paragraph 1 is deleted and sub-paragraph 5 (e) becomes sub-paragraph 5 (d).
- (b) In sub-paragraphs 7 and 8 of paragraph 1, delete the punctuation and word gratuity.
- (c) In sub-paragraph 14 of paragraph 1, delete the words and figures "31 March 1981" and substitute therefore the words and figures "31 March 1986".

If these proposals are acceptable to the Government of Lesotho, I have the honour to suggest that this Note and your reply shall constitute an agreement between our two governments, which shall enter into force on 31 March 1981, and which shall be cited, together with the Agreement, as the Overseas Service (Lesotho) (Continuance) Agreement 1971/81.
