## EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF

THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF SINGAPORE FURTHER AMENDING THE AGREEMENT FOR AIR SERVICES BETWEEN AND BEYOND THEIR RESPECTIVE TERRITORIES, SIGNED AT SINGAPORE ON 12 JANUARY 1971, AS AMENDED

Your Excellency

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Singapore for Air Services between and beyond their Respective Territories, signed at Singapore on 12 January 1971 as amended by Exchanges of Notes of 27 May/14 June 1976<sup>2</sup>, 23/30 August 1978<sup>3</sup> and 28 March 1980<sup>4</sup> and to subsequent discussions which have taken place between representatives of the two Governments.

As a result of these discussions, it was agreed that the Agreement, as amended, should be amended further by substituting for the Schedule thereto the revised Schedule annexed to this Note.

If the foregoing is acceptable to the Government of the Republic of Singapore, I have the honour to propose that this Note together with its Annex and your Excellency's reply to that effect shall in accordance with Article 14 of the aforementioned Agreement constitute an Agreement between our two Governments in this matter which shall enter into force on the date of your reply.

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
