Her Majesty's Embassy at Athens to the Ministry of Foreign Affairs of the Hellenic Republic

Note No. 12

Her Britannic Majesty's Embassy present their compliments to the Ministry of Foreign Affairs and have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Hellenic Republic on the International Carriage of Goods by Road, signed at London on 26 February 1974¹, and, acting on instructions from Her Majesty's Principal Secretary of State for Foreign and Commonwealth Affairs, have the honour to propose that Article 1(c) of the said Agreement be amended to read as follows:

“(c) For the purpose of this Agreement, the term ‘territory’, in relation to the United Kingdom, shall mean England, Wales, Scotland, Northern Ireland and the dependent territory of Gibraltar”.

If the foregoing is acceptable to the Government of the Hellenic Republic, the Embassy have the honour to suggest that the present Note and the Ministry's reply to that effect shall constitute an Agreement between our two Governments which shall enter into force on the date of the Ministry's reply.

Her Britannic Majesty's Embassy avail themselves of this opportunity to renew to the Ministry of Foreign Affairs the assurance of their highest consideration.
