Your Excellency,

I have the honour to inform you that with reference to the recent discussions between our Governments that it is the intention of the Government of the United Kingdom of Great Britain and Northern Ireland (hereinafter referred to as the Government of the United Kingdom) to provide assistance to the Hashemite Kingdom of Jordan (hereinafter referred to as the Government of Jordan), as recommended by the Trade and Development Board (TDB) of UNCTAD, in the form of adjustment to the terms of the following loans:

- 2. The amounts and due dates of the above payments are set out in Annex 1 to this Note.
- 3. Save to the extent to which the Government of the United Kingdom notifies the Government of Jordan otherwise in writing the Government of the United Kingdom shall hereby waive all payment of arrears due up to and including 27 July 1994. All payments due on or after 28 July 1994 (set out in Annexes 1 and 2 to this Note) shall be waived as from the date that such payment fall (or fell) due.

- 4. All other terms and conditions of the aid loans and debt rescheduling agreements (referred to in paragraph I above) shall continue to apply.
- 5. If the foregoing proposals are acceptable to the Government of Jordan I have the honour to propose that the present Note, together with its Annexes, and Your Excellency's reply in that sense, shall constitute an Agreement between the Government of the United Kingdom and the Government of Jordan which shall enter into force on the date of Your Excellency's reply, and which shall be known as the "United Kingdom/Jordan Retrospective Terms Agreement 1994".
- 6. I avail myself of this opportunity to renew to your Excellency the assurances of my highest consideration.
