Your Excellency,

I have the honour to refer to the Exchange of Notes between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Union of Soviet Socialist Republics concerning the Mutual Abolition of Consular Fees on Visas signed at Moscow of 13 April 1964.<sup>1</sup>

I would like to propose that, notwithstanding paragraph 2(C) of the said Exchange of Notes, the agreement constituted by the said Exchange of Notes be terminated as between the Government of the United Kingdom of Great Britain and Northern Ireland and the Republic of Armenia forthwith.

If the above is acceptable to the Government of the Republic of Armenia I propose that this Note and Your Excellency's reply to that effect shall constitute an agreement between our two Governments in this matter, which shall enter into force on the date of Your Excellency's reply.

I avail myself of this opportunity to renew to Your Excellency the Assurance of my highest consideration.
