EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF NEW ZEALAND FURTHER AMENDING THE AGREEMENT CONCERNING AIR SERVICES DONE AT LONDON ON 4 OCTOBER 1982¹

The New Zealand High Commission to the Foreign and Commonwealth Office

The New Zealand High Commission presents its compliments to the Foreign and Commonwealth Office and has the honour to refer to the Agreement between the Government of New Zealand and the United Kingdom of Great Britain and Northern Ireland Concerning Air Services of 1982, as amended, and to the Memorandum of Understanding of 7 August 1997 between the aeronautical authorities of New Zealand and the aeronautical authorities of the United Kingdom of Great Britain and Northern Ireland.

In accordance with paragraph 3 of the Memorandum of Understanding of 7 August 1997, the High Commission has the honour to propose that the Route Schedule contained in the Annex to the Air Services Agreement be replaced as follows:

"ROUTE SCHEDULE

SECTION 1

Route to be operated by the designated airline or airlines of the United Kingdom.

Points in the United Kingdom—Intermediate points—Points in New Zealand—Points beyond.

Note

- 1. Intermediate points or points beyond may be omitted on any flights provided that the service begins or ends in the United Kingdom.
- 2. On services operated on the above route, traffic rights to and from intermediate and beyond points may only be exercised as from time to time agreed by the aeronautical authorities of the Contracting Parties.

SECTION II

Route to be operated by the designated airline or airlines of New Zealand.

Points in New Zealand—Intermediate points—Points in the United Kingdom—Points beyond.

Note.

1. Intermediate points or points beyond may be omitted on any flights provided that the service begins or ends in New Zealand.

2. On services operated on the above route, traffic rights to and from intermediate and beyond points may only be exercised as from time to time agreed by the aeronautical authorities of the Contracting Parties."

If the foregoing is acceptable to the Government of the United Kingdom of Great Britain and Northern Ireland the New Zealand High Commission has the honour to suggest that this Note and the reply of the Foreign and Commonwealth Office constitute an amendment to the Agreement between the Government of New Zealand and the Government of the United Kingdom of Great Britain and Northern Ireland concerning Air Services which shall enter into force on the date of receipt of the reply of the Foreign and Commonwealth Office.

The New Zealand High Commission takes this opportunity to renew to the Foreign and Commonwealth Office the assurances of its highest consideration.
