

**2014 No. 1535 (W. 157)**

**ROAD TRAFFIC, WALES**

**The M4 Motorway (Slip Roads  
between Junction 38 (Margam) and  
Junction 43 (Llandarcy), Neath Port  
Talbot) (Temporary Prohibition of  
Vehicles) Order 2014**

*Made* 11 June 2014

*Coming into force* 16 June 2014

The Welsh Ministers, being the traffic authority for the relevant length of the London – South Wales Motorway (M4) (hereinafter referred to as “the motorway”), are satisfied that traffic in specified lengths of the motorway should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**Title, Interpretation and Commencement**

**1.** This Order comes into force on 16 June 2014 and its title is The M4 Motorway (Slip Roads between Junction 38 (Margam) and Junction 43 (Llandarcy), Neath Port Talbot) (Temporary Prohibition of Vehicles) Order 2014.

**2.** —(1) In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used for the emergency services or in connection with the works giving rise to this Order;

“the lengths of the motorway” (“*y darnau o’r draffordd*”) means those lengths of the motorway between Junction 38 and Junction 43 in the County Borough of Neath Port Talbot specified in the Schedule to this Order;

“works period” (“*cyfnod y gwaith*”) means that period commencing at 20:00 hours on 16 June 2014 and ending when the temporary traffic signs are removed permanently.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

### **Prohibition**

3. Subject to the provisions of article 4, no person shall, during the works period, drive any vehicle or cause or permit any vehicle, other than an exempted vehicle, to proceed in the lengths of the motorway specified in the Schedule.

### **Application**

4. The provisions of article 3 apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

### **Duration of this Order**

5. The maximum duration for this Order shall be 18 months.
